a. Jordan Reilly -1219 Felix- could not attend the work session but came to address the LC about 120 N. 13th. He has signed and will have it under contract within the week. He desired to discuss the emergency stabilization fund. He wanted to know the process of applying for the funding.

Des Planques has only emailed two other cities and has yet to receive a response from them.

Reilly mentioned that if the funding was only approved for tarps and temporary fixes, that would be less than helpful for this specific site.

Johnson agreed that he would like to see the funding go towards structural repairs like roofs, walls, etc.

Rock suggested eliminating the pre-application meetings in order to allow people to take advantage of the funding in emergencies.

b. Brenda Reilly also added that the SOHG funding has been extremely helpful to the city. Manning confirmed that well over \$3 Million had been added to the economy from the funding.
