Missouri Theater Upcoming CIP Projects The CIP project order has not been finalized yet. Missouri Theater restrooms on the draft would be our first project. The restrooms would be on one end of the lobby and ADA compliant. Second project listed is the curtain replacement. The current curtain had been brought in from another location. The other project would be lighting replacement throughout the theater. They would probably be LED, which would last longer. The challenge will be to upgrade the lighting, but

still keeping the historical look.

Question on sound system: the system has been done through donations

approximately \$500,000.

Bartlett Restroom and Decorative Fencing

The restroom is complete with the exception of the electricity. We are waiting on KCP&L to get everything hooked up. Tuesday we installed the decorative fencing. This has made the area more attractive. Plans are to have the ribbon cutting ceremony late October. We want to do something a little bit different and make it more geared for kids. Maybe get some of the sport mascot to participate. Really not for sure what we will finally end up having.

Question on security cameras: we do not have funding currently for them only

Krug and Aquatic Park right now.

Tennis Court Renovations Noyes courts have been bid out and the bids awarded to Herzog with McConnell & Associates going in with them. The contracts have been signed today. We will begin the 3rd week of October with removal of the mesh and nets when girl's high school tennis is over. Herzog will be responsible for all other areas. Parks and Public Works will be assisting them with disposal of material. Look for actual surface work to be in the spring. Hope is to have it done before

the next high school season begins, weather permitting.

<u>Hyde Park/Northside Tennis Courts</u> – we have been notified by the contractor that they will be unable to complete the work before winter. Will need to be delayed until spring. <u>CIP Project</u> – a preliminary schedule has been worked on by city staff. Council will be presented with the schedule at an upcoming work session. The schedule is difficult to set with figuring in projects that might have grants, fundraisers, etc. time restraints. Usually have around 4 million for each year of the CIP. The proposed schedule does not have us with any large projects for the first year only some design/behind the scenes work.
